Market Review

Global financial markets delivered mixed but generally positive returns in June as easing geopolitical tensions and resilient corporate earnings supported investor sentiment. A ceasefire agreement between the United States and Iran helped alleviate concerns surrounding global energy supplies, resulting in a sharp decline in oil prices and encouraging investors to increase exposure to risk assets. While central banks remained cautious on inflation, markets increasingly focused on company earnings, valuation opportunities and the outlook for growth.

Performance across equity markets varied by region and sector. In the United States, investors rotated away from some of the strongest-performing technology and artificial intelligence (AI) stocks and into sectors such as financials, healthcare, industrials and utilities. Despite this shift, major indices remained resilient. The Russell 2000 gained approximately 3.6%, outperforming larger-cap indices, while the Dow Jones Industrial Average also posted solid gains. Technology stocks experienced greater volatility following a strong run earlier in the year, although the sector continued to benefit from long-term optimism surrounding AI-related investment. Corporate earnings expectations remained supportive, helping underpin broader market valuations despite elevated share prices.

European equities were among the strongest performers globally during the month. Lower energy prices provided support for businesses and consumers, while improving earnings expectations boosted investor confidence. Financials, industrials and consumer-related sectors delivered particularly strong returns. European markets also benefited from a relatively attractive valuation backdrop compared with the United States, attracting additional investor flows.

Japanese equities continued their strong performance, supported by healthy corporate earnings, ongoing governance reforms and continued foreign investor demand. A weaker yen provided a further boost to export-oriented businesses, helping Japanese shares outperform many developed market peers.

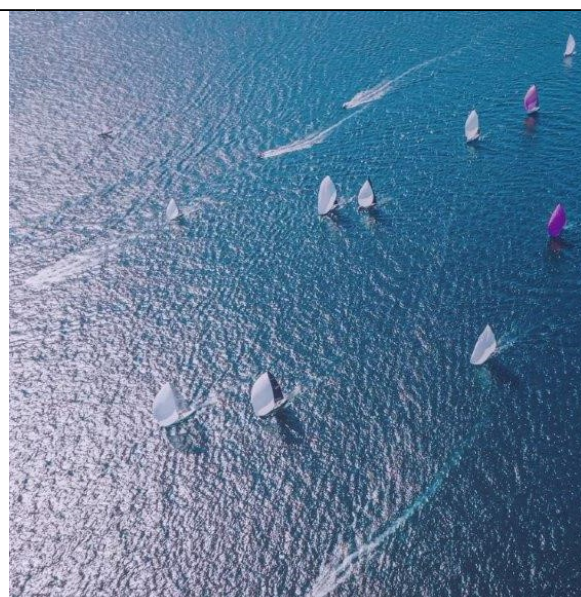
Emerging markets delivered mixed returns during June, with China remaining a relative laggard as investors continued to assess challenges within the property sector and broader domestic economy. Elsewhere, Taiwan and South Korea benefited from ongoing demand for semiconductor and AI-related companies, although gains moderated following the strong rally earlier in the year. Long-term investment themes linked to digital infrastructure and artificial intelligence continue to support the outlook for many Asian technology businesses.

Australian markets generated modest gains with the S&P/ASX 300 Accumulation Index rising by approximately 0.6% during the month, while the S&P/ASX Small Ordinaries Index declined around 2.0%. Resource stocks were weaker as oil, copper and gold prices retreated from recent highs, although healthcare, consumer staples and consumer discretionary companies delivered positive returns.

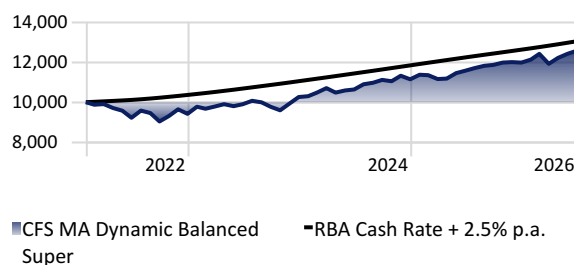
Bond markets generally produced positive returns globally. Falling oil prices and moderating inflation expectations supported government bond markets, while corporate credit performed well as investor confidence improved and credit spreads narrowed.

Overall, resilient earnings, easing geopolitical risks and improving investor sentiment continued to support financial markets despite ongoing policy uncertainty.

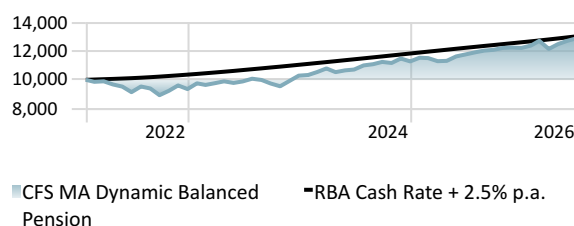

\$10,000 invested over time - Pension

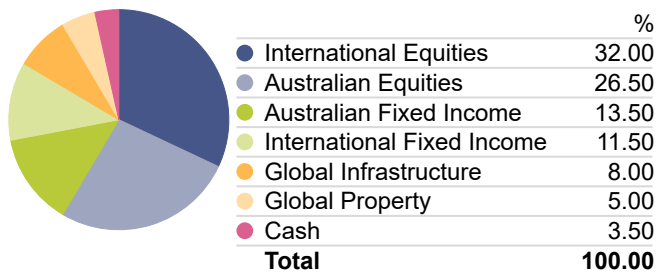

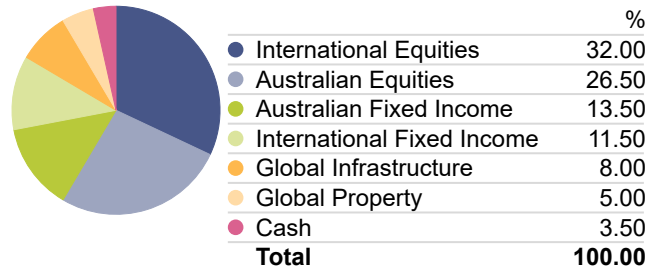
Current Asset Allocation - Super

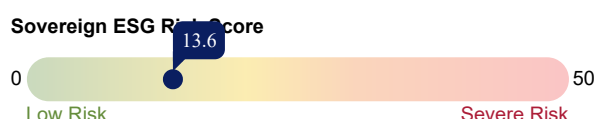
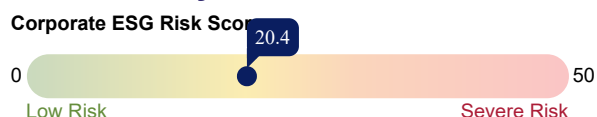
